Risks, Issues & Decisions

- Further FP17W changes have been requested and agreed with NHSBSA for 2019-20, including ability to report all activities carried out by DCPs via FP17W. There has been some delay in implementing these changes. Awaiting date from NHSBSA for completion/roll-out.

Activities for the Next Reporting Period

- Work is being planned within the Welsh Government to start reviewing current dental legislation and identifying changes to support the GDS Reform Programme.
- HEIW Quality Improvement Educators are setting up local QI groups for peer review, QI and CPD.
- New practices to join the programme from April 2020
- Associate innovators programme team in North Wales to work on developing a periodontal patient pathway – Draft will be shared at the Dental Symposium May 6th for comment and feedback
- In the process of commissioning insight work to understand dental practices' perspective on implementing changes related to the GDS reform programme
- Public Survey looking at views of changes proposed through the GDS Reform Programme. Report due from Bangor University at the end of January. This will be shared once translated into Welsh.
