Programme Update

- There are now 12 practices across Wales who have moved to stage 2 of the programme, see table below.
- Mid year reports released from the NHS BSA
- Programme Steering Group meeting held, draft minutes circulated to the membership.
- Minor change made to ACORN and re-circulated to practices the latest version is 1.2.
- Letter from the CDO emailed to all GDS reform practices on 4th Oct '19 providing guidance on under 25's and over 60 year old patients who are entitled to a free examination.
- Feedback received on quarterly and end of year reports has been provided to the NHSBSA.
- GDS Q&S Forum met in October and the NHS BSA colleagues presented on monitoring reports to the DPAs and other health board colleagues. The presentation focussed on correct interpretation of the new monitoring report.

Further FP17W changes have been requested and agreed with NHSBSA for 2019-20, including ability to report all activities carried out by DCPs via FP17Ws. There has been some delay in implementing these changes. Awaiting date from NHSBSA for completion/roll-out.

Activities for the Next Reporting Period

- Work is being planned within the Welsh Government to start reviewing current dental legislation and identifying changes to support the GDS Reform Programme.
- Planning started for January engagement events with a view to changing the format of the session to tailor them to fit with practices at different stages of the programme.
- Scope venues and dates for Dental Symposium 2020 as soon as a date and venue have been confirmed this will be shared. Late April/early May date is being considered. It is most likely to be held in Cardiff.
- Steering Group meeting due to be held on 26th November 2019
- Powys Teaching Health Board are holding an event on 15th November in Llandrindod Wells <u>–</u> with an exciting agenda and update on GDS Reform included.
- Some other Health Boards are also holding local engagement events.
- HEIW Quality Improvement educators are in process of setting up local QI Groups in each health boards, a new way of CPD.
