## **WG Health and Social Care Policy Leads**

Alex Slade, Deputy Director of Primary Care, reflected that clusters are well placed to deliver a seamless whole system approach to health and social care delivery, with services from different providers seamlessly coordinated, suggesting going beyond traditional service boundaries to make a difference to individuals.

Albert Heaney, Chief Social Care Officer for Wales, reflected that many individuals may need support to stay well, healthy & connected to their communities. The challenge was set to find ways to work across organisational boundaries and with our communities to find preventative solutions that result in better outcomes for people & create better efficiency within our health & social care system. An excellent example of social prescribing activity in Anglesey cluster and the benefits across Wales was provided.

## Reflections on the day

Nick chaired at reflection session with Alex Slade, Dr Owen Thomas, Alan Lawrie and Sue Morgan, each of whom were given the spotlight for three minutes.

Alex reflected on the Ministers expectations for change to be driven at a local level and to think beyond the four Primary Care contractors to bring wider services into the cluster focus.

Owen noted the lack of clarity on what ACD means practically, suggesting more discussion is required on delivery with practical ideas shared and local engagement progressed.

Alan confirmed that local flexibility and empowerment to drive implementation is key, further detail & communication is required.

Sue closed with the reflection that ACD is 'integration in action
